# MILESTONE PROJECTS

Our Milestone Projects are culminating assignments that provide students with the opportunity to extend their learning beyond the classroom. In these interdisciplinary projects, students are asked to apply learning they have acquired within their classroom to new situations. These projects are the cornerstone of our programs, and students look forward to them all year. In addition, students are always full of anticipation for the projects that await them in future years.

Because of the pandemic, the Milestone Projects needed to be reimaged. Many took place virtually, with students presenting to their classmates and families over Zoom. Our students learned to collaborate in new ways and enhanced their film and video presentation skills. Among the projects moved to a virtual platform was the Fourth Grade Action Research Project. Our Fourth Grade students were still able to present their findings to the Hoboken City Council, albeit on Zoom.

Fortunately, some projects were able to occur in person. Later in the school year, projects could take place outside (and distanced). Second-Graders went to the Brooklyn Bridge in June to celebrate their study of bridges and New York City.

Some of the changes made by necessity have allowed us the opportunity to evaluate the Milestone Projects and incorporate new elements to strengthen our students' experiences and learning opportunities.

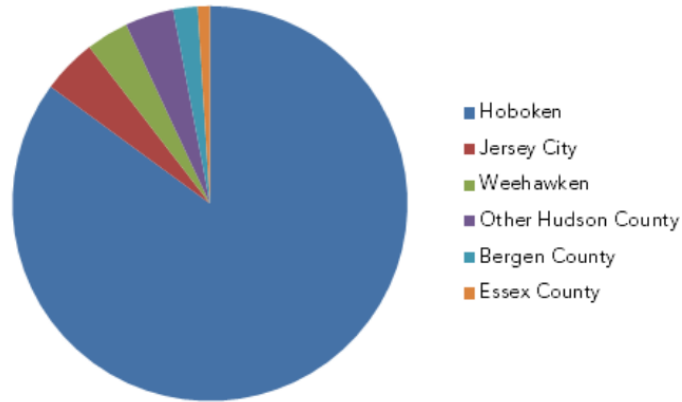

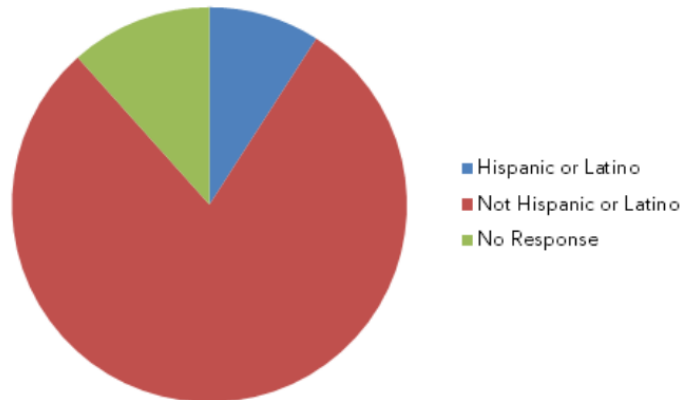

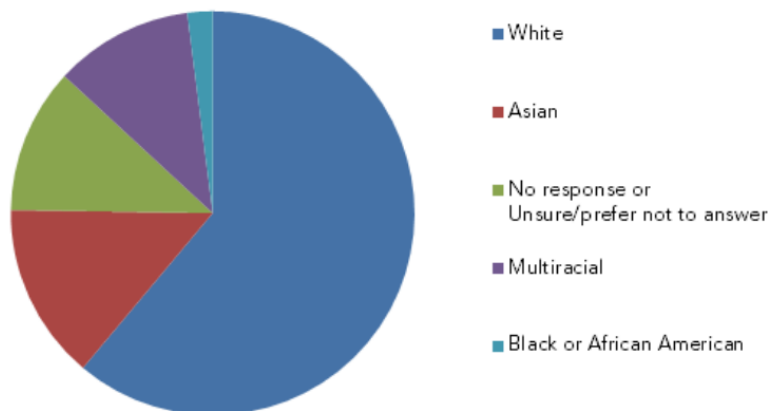
